#### **CONSTITUTIONAL RESPONSIBILITIES**

Article 10.7 of the MSU Constitution sets out the constitutional responsibilities of the MSU Vice President Education. I have outlined my constitutional responsibilities below and have commented on my progress in fulfilling them.

#### List of Constitutional Responsibility:

The Vice President Education shall be responsible for dealing with issues of academic interest and general academic advancement of the student body of the University.

I have continued to deal with issues of Academic Interest and Academic Advancements within MU and SPPU when I was able to.

This involved case work and attending committee meetings.

One significant thing is that the Dean of Teaching and Learning in the ACSP Faculty asked if it is possible to elect Academic Reps sooner, I communicated the difficulties that surround this issue. These are:

- Constitutionally, we have two weeks for nominations followed by two weeks of campaigning.
- If we move the notice of elections earlier, students will not be on campus when nominations are open.
- We could elect continuing students but we would face difficulties if students
  do not pass to the subsequent year or if something happens throughout the
  summer to those elected.
- If the above point is practiced, we would have to put additional time and resources the future VP Education may not have into elected 1<sup>st</sup> year students.

As a member of the CRRC, this is something I will be exploring.

Be responsible for dealing with all academic-related casework by:

(a) Acting as a point of peer-provided guidance

#### (b) Acting as a listening & referral service

I have continued to offer peer support and to act as a listening and referral service, especially as it is assignment season, I am finding myself referring a lot of students to various supports and services on campus.

They shall be responsible for updating members on changes in the education system or changes within the educational structure of the University which are relevant to students.

There has been no changes during this period however, I continue to represent students on various academic committees.

They shall be responsible for developing and enacting all Union educational policies and campaigns.

Tuesday October 8<sup>th</sup> I hosted a baby DeStress campaign. The plan of this campaign is to welcome students back to campus after reading week with a daytime social event followed by informational graphics.

On Tuesday October 8<sup>th</sup>, The Wooly Pet farm visited campus. I did an ethical research on various farms. This included:

- Research on the background of the farm
- Animal Safety Policies
- Animal Welfare Policies
- Distance animals would have to travel to get to campus
- Animal safety regulations when they visit campus

As well as ethical research, I researched and reached out to a great number of animal sanctuaries, however none of them had appropriate measures and documents for attending campus.

It was great to see vibrant groups of students outside Maynooth Students' Union on the day.

From the informational point of view, following the University's Governing Authority announcement, I didn't want to overload the MSU social media and I didn't want the messaging of the student centre or assignments to get lost in the feed which often happens when multiple posts are uploaded at once. As a result of this, Sunday, Nov 13<sup>th</sup>, I uploaded informational graphics.


The aim of these graphics were to:

Overall, in my opinion, the campaign was a great success, especially the graphics as they reached 7,165 Instagram accounts and received almost 100 saves.

The first Academic Assembly took place at Academic Rep training. The function of this meeting was fulfilled here and I will call for another Academic Assembly if it necessary.

Faculty Assemblies are set to take place this week and next.

I had hoped to get NStEP and Mental Health training for Friday Nov. 18<sup>th</sup>, however, NStEP Training will now take place on the W/S Dec 5<sup>th</sup>.

They shall endeavour to attend all meetings of committees of which they are member and to coordinate and maximise student representation on other appropriate academic structures.

I have attended all committees when I was available to. For more information, please see committees section.

They shall endeavour to represent the needs of students by campaigning at both local and national level.

As this campaign draws to a close, here are the key points of this campaign:

- Monday, 26 September 2022 | Maynooth University announced that construction on a new Student Centre project has been terminated, following a decision by the University's Governing Authority.
- I was Present at GA when the contract was terminated. I was one of the voters who was voted against the termination.
- RTÉ Drivetime interview
- I was interviews by RTÉ Drivetime and asked about the termination of the Student Centre Construction.
- Monday, 3 October 2022 | MSU launches its Online #WheresMyLevy petition calling on the Minister for Further and Higher Education, Research, Innovation and Science (FHERIS), Simon Harris TD, to support the students of Maynooth

in these demands and to aid them in bringing them to the attention of Maynooth University.

- We worked hard to circulate this survey to students and alumni.
- Monday, 3 October 2022 | The MSU President wrote to the Bursar seeking a freeze to the levy with no increases to the charge for a period of at least five academic years beginning 2023-24. The MSU President received no reply.
- Tuesday, 4 October 2022 | MSU launches its paper #WheresMyLevy petition
   calling on Maynooth University to:
- 1) publicly state their commitments to delivering a student Centre and ensure its prioritisation over other capital developments on campus,
- 2) freeze the levy, with no increases to the charge for a period of at least five academic years beginning 2023-24, and
- 3) be transparent in its communication as to how the student levy is being used, prove their commitments to joint oversight of the fund, and work in good faith with MSU and the students of Maynooth to regain their trust.
- This part of our campaign involved countless hours of the Sabbatical team and volunteers as they got as many signatures as possible.

- Thursday, 6 October 2022 | MSU organises #WheresMyLevy #LevyWalkOut with hundreds of students walking out in support of the #WheresMyLevy campaign
- Thursday, 6 October 2022 | The MSU President and I met with Minister Harris to outline the concerns of the students of May.
- Tuesday, 25 October 2022 | Students walk to Riverstown to hand deliver the signed petitions to the MU President.
- Thursday, November 10, 2022, MU Governing Authority took place in the JH
   Board Room
- In this GA, the MU President proposed the Student Centre action group. All of the demands of MSU were met
- This was a significant campaign and now that it is finally coming to a close, I want to give a special shoutout to the MSU President and Director General for all of their hard work throughout this period.

For the time that the Union is a member organisation of the Union of Students in Ireland, the Vice President Education shall be a delegate to the National Council and Annual Congress of the Union of Students in Ireland.

There has been no Comhairle Náisiúnta in this work period.

#### PLAN OF WORK

At the beginning of this Executives term of office, we created a plan of work. The Plan of Work is the guiding document for the executive. Below is how I have contributed to the completion of the Plan of Work.

- I met with the MSU President on Sunday 13<sup>th</sup> November to adjust the Plan of Work and to have it finalised before the next week.
- This document has been circulated to senators to ensure they have adequate time to give their feedback with enough time for adjustments to be made prior to the next senate so a senate consulted Plan of Work can be approved at the next meeting of the MSU Student Senate.
- The MSU Executive are hosting drop in consultation sessions for senators to contribute to the Plan of Work. These will be mainly in person with one online to accommodate those on and off campus.

#### 1. Maynooth University Governing Authority

The Governing Authority has responsibility for the strategic direction of the University, the management and administration of its revenue and property and the general conduct of its affairs.

I attended GA on November 10<sup>th</sup>. You would have received an all student email with an update on the Student Centre. It is great to see all of the hard work of the #WheresMyLevy campaign pay off as all three of the demands of MSU were met during this meeting.

In AOB of GA, I raised a reoccurring Sexual Harassment issue which has been brought to our attention. I asked the MU President who to contact as the third party company's management are yet to respond to the complaints which have been filed. It is important to note this in my Officer Report and to flag this with the University. I will be following up with those who I was advised to contact

#### 2. Maynooth University Academic Council

The Academic Council Office facilitates the co-ordination of business and liaison between the Academic Council and its standing boards/committees, and when required, the three Faculties and Governing Authority. It is responsible for the preparation and circulation of documents for meetings of the Academic Council and its boards and committees.

I attended Academic Council on Monday November 7th.

#### 3. Maynooth University Faculty of Arts, Celtic Studies and Philosophy

The Faculty is a forum for consideration of academic matters relevant to the Faculty. It may make recommendations to Academic Council on matters on which Academic Council is empowered to make decisions.

The ACSP Faculty has not met in this period.

#### 4. Maynooth University Faculty of Social Sciences

The Description above (see ACSP Faculty) is relevant to all three MU Faculty meetings.

The SS Faculty has not met in this period.

#### 5. Maynooth University Faculty of Science and Engineering

The Description above (see ACSP Faculty) is relevant to all three MU Faculty meetings.

The S&E Faculty has not met in this period.

#### 6. Maynooth University Academic Programmes Committee

The function of the Academic Programmes Committee is to oversee on behalf of Academic Council the portfolio of programmes of the University, undergraduate and postgraduate, to ensure that they remain appropriate, relevant and of the highest possible standards. The Academic Programmes Committee will bring recommendations to Academic Council regarding the overall structure of the portfolio, the approval of new programmes, changes to programmes, the withdrawal of programmes and the academic regulations governing programmes. The Academic Programmes Committee will seek the prior approval of the University Executive before making any recommendation to Academic Council that has significant resource implications.

The Academic Programmes Committee has not met in this period.

#### 7. Maynooth University Strategic Plan steering group

This committee looks at and reviews the feedback given at town halls relevant to the Strategic Plan.

The MU Strategic Plan steering group has not met in this period.

#### 8. Maynooth University Student Success initiative

The Student Success Initiative has not met in this period.

#### 9. Maynooth University Teaching and Learning Committee

The role of the Academic Council Teaching and Learning Committee is to make recommendations to Academic Council on matters of strategy and policy in relation to Teaching and Learning in order to enhance teaching, learning and assessment at undergraduate and postgraduate levels, and to oversee, on behalf of Academic Council, the development, implementation and review of the education strategy for the university, within the overall framework of the University Strategic Plan

The T&L committee has not met in this period.

#### 10. Maynooth Students' Union Executive Committee

The Executive shall meet and act as a collective authority, and shall be collectively responsible for the day to day operation of the Union, in addition to each officer's own portfolio, and shall have powers to take necessary decisions in between meetings of the Student Senate. Any such decisions must be ratified at the next meeting of Student Senate and shall lapse and have no further effect if not so ratified.

As the Vice President Education, I am the secretary of the Maynooth Students' Union Executive.

I have attended each of the MSU Executive meetings.

This year, we have started to publish an *Achoimre* of the Executive meetings on the MSU website. I have some minutes and achoimre to finish, but when they are finished and approved by the Executive, they will be uploaded.

#### 11. Maynooth Students' Union Student Senate

The governing body of the Union shall be the Student Senate. Subject to the provisions of the law, this Constitution, and to policies set by Policy Referendum, Union policy on matters shall be determined by the Student Senate at a validly called and quorate Student Senate meeting. Union policy shall include mandates for Union Officers and Union delegations.

The functions of the Student Senate shall include inter alia;

- 1. The formulation of Union policy
- 2. The right to mandate the members of the Union Executive individually or as a body to undertake certain tasks in additional to any adopted policy;
- 3. Ensuring that the members of the Union Executive are held accountable in the conduct of their respective roles

I attended the MSU Student Senate on November 9<sup>th</sup>, 2022 in the John Hume Board room.

#### 12. Maynooth Students' Union Academic Assembly

There shall be Academic Assembly to provide a forum to discuss issues related to academic affairs, teaching and learning, and quality assurance, as well as areas that

influence student learning, as they affect all students across the University so as to be in a position to advise the Vice President Education and the Union where necessary.

As the Vice President Education, I chaired the first Academic Assembly on Friday November 21<sup>st</sup>. For more information, see the Academic Rep training schedule previously outlined in the report.

#### 13. Maynooth Students' Union Student Charter Committee

The Student Charter Committee is established by the Student Academic Assembly to review and develop the Student Charter

The first meeting of the MSU Student Charter Committee will convene after the Second meeting of the Faculty Assemblies.

This is because only two Academic Representatives were elected to the committee during the first Faculty Assemblies and to ensure effective representations, we will open nominations again in the next assembly.

14. Maynooth Students' Union Student Engagement and Feedback Committee

The Student Engagement & Feedback Committee is established by this Constitution

and the Student Academic Assembly to review the mechanisms for students to

provide feedback on the quality of their teaching and learning as well as the teaching

and learning environment within the University

The first meeting of the MSU Student Engagement and Feedback Committee will convene the week starting 14<sup>th</sup> November.

15. Maynooth Students' Union Academic Representation Review Committee

The Academic Representation Review Committee is established by this Constitution
and the Student Academic Assembly to review and advise the Vice President

Education on the effectiveness and development needs of student academic representation in the Union and University

The first meeting of the Academic Representative Review Committee will convene the week starting 14<sup>th</sup> November.

## 16. Maynooth Students' Union Arts, Celtic Studies and Philosophy Faculty Assembly

There shall be Faculty Assemblies to provide a forum for discussion on all issues of particular relevance to a particular faculty, including, but not limited to: academic programmes; all areas of teaching and learning; facilities; and all matters relating to the education, welfare and student experience of students in the relevant faculty

The ACSP Faculty Assembly has not met in this period.

#### 17. Maynooth Students' Union Social Sciences Faculty Assembly
